Financial Agreement 2018

- 1) Registration fees and team fees for the MPHFC are determined on an annual basis, and these fees are subject to change each year. Registration fees cover costs for such items as coaching, training, referees, summer camp, spring league fees and fall league fees. As the parent/guardian of the undersigned player, I/we acknowledge our obligation to pay our assessed fees in full and on time as outlined by the Club.
- 2) The Club expects that all parents/guardians will pay the league registration fees by the due date set by the Club unless other arrangements are made with the Club prior to the due date. Once a player has registered with an MPHFC team, that player is financially committed to the Club and team for the entire season, including, but not limited to all Club registration fees and team related fees. A player may not leave the Club to join another soccer club until all outstanding financial obligations to the Club and the player's team has been paid in full. In the event a player attempts to join another soccer club prior to paying all such amounts, the Club reserves the right to pull that player's pass. The player will also be placed in bad standing with the appropriate governing bodies until such time as all such amounts have been paid in full.
- 3) During the time that a player may be injured or sick, the Club will maintain the player's roster spot on the team as long as registration or team fees paid are kept current.
- 4) If a player is dismissed from a team for disciplinary reasons, there will be no refund of the registration or team fees paid, and there will be no waiver or forgiveness of any outstanding financial obligation due to the Club or team.
- 5) If a parent/guardian fails to fulfill the financial obligations set forth herein, the Club reserves the right to pull that player's pass, and that player will be placed in bad standing with the appropriate governing bodies until such time that the financial obligation is satisfied. During this time, the affected player will not be allowed to participate in practices, games, events or other Club activities.
- 6) The Club offers scholarships to cover up to 50% of registration fees, and in rare occasions, other fees owed to the Club. Scholarships are not awarded for a player's team fees. Team fees remain the obligation of the individual player. Scholarships are available on a limited basis to players meeting certain requirements and further accepting certain obligations to the Club. Complete details on the Club's scholarship program are available through MPHFC's Executive Board. An application for a scholarship is not a guarantee or a promise that scholarship will be awarded, and a player should not accept a roster spot under the expectation that funds will be available to assist them in meeting their financial obligations.
- 7) The Club refund policy states that a refund of registration fees minus \$275 will be awarded if a request for a refund is made prior to June 1, 2018. After June 1st 2018, the lesser of either 50% or \$450 refund of registration fees will be awarded if a request for a refund is made prior August 1, 2018. No refunds of registration fees will be given after August 1, 2018.
- 8) This Agreement must be signed by any parent, guardian, or person acting as a parent or guardian, who expects to be treated by MPHFC and its coaches as a player's parent for purposes of participating in conversations or receiving communications about the player and his or her team.
- 9) You are expected to fully support both club and team fundraising events. Some of these events may have minimum requirements for fundraising for each club member or a buy-out option if you chose not to participate. Funds raised for Club fundraisers will be used to help defray Club expenses and could result in lower registration fees in subsequent years. If you do not chose the buy-out option, then you will be asked to participate in the fundraiser and are obligated to raise the amount determined by each fundraiser. Opting out of a Club fundraiser does not relieve you of the team fundraisers that you may be asked to participate in. Team fundraisers are unique to each individual team and to be determined by the team.
